Visa Info: Turkmenistan

All Pakistani citizens must obtain a visa to enter Turkmenistan. We suggest that you write or fax the Embassy your request for a visa. Please inform the Embassy of your name and address or fax number. You will receive an application that must be fully completed for a visa to be issued.

Obtaining a Visa

Please read carefully the instructions below. Completed applications should be directed to the Embassy of Turkmenistan:

- All Applicants should obtain a new 2008 edition of Visa Application Form from the Embassy of Turkmenistan in Islamabad. Or download it Online.
- Please fill in the Visa Application (one copy only) with recent passport size photo glued to form.
- Do not staple pictures. In the application, supply dates in the order of day-month-year.
- Submit a signed passport (valid for at least 6 months from the date of departure) along with a copy of its 1st page (showing bearer's details and signature), arranged vertically into the upper part of a standard Letter Size paper.
- The Embassy must have the original passport to process a visa.
- Submit money in CASH US dollars (Visa Cost Schedule).
- Submit a letter of invitation from the person or company to be visited certified by the State Migration Service of Turkmenistan.
- The invitation is valid only for 3 (three) months from the date it was confirmed.
- If you are traveling as a tourist and will not be meeting anyone in Turkmenistan, you must contact any of travel and tourism agencies or companies in Turkmenistan. E.g. "Turkmen Syyahat" Tel: (993-12) 35-47-77, 39-86-91; Fax: (993-12) 39-67-40 or 39-00-65, 39-77-71. You can also visit them at www.tourism-sport.gov.tm for additional information and services available. In addition to the requirements listed above, residents of Pakistan must submit a copy of their ID Card

Checklist

- 1-One Visa Application per person
- 2-Passport and its copy as described above
- 3-One passport size photo glued to the Application
- 4-Cash payable to the Embassy of Turkmenistan
- 5-Certified letter of invitation

The processing time for a visa is 3-10 business days. It is possible, however, to expedite the process to three business days if the application is complete, the paperwork is in order, and an additional 100% of the cost of the visa is included in the payment. Please, note that the answers to questions on the visa application will be reflected in the issued visa and should match those submitted in original documentation in Turkmenistan. Visa Cost Schedule

Fees vary for the following countries: Afghanistan, Azerbaijan, Belgium, Georgia, Germany, Kazakhstan, Kyrgyzstan, Tajikistan, United Kingdom, Uzbekistan; please make prior check. Fees must be paid in Cash, in US dollars only, payable to the EMBASSY of TURKMENISTAN. Expedited visa – 3 business days, 100% surcharge. Children 0-7 years of age – no charge; 7-16 – 50% of regular fee.
